Sitework will resume next week. Curtain walls installation is ongoing. Interior framing sheetrock is ongoing in Building A. Elevator is being installed, but the certificate will not be given until May. Kitchen floor tile will start around the beginning of April. Carpet is stored off site. The building systems equipment has been received and is all on site. Building is going well and is on schedule.
