## VI. NEW BUSINESS

1. During the snow storm in January there was a great deal of snow that got into the WHS attic. Mr. Darling is a consultant from BPD Roofing. He has been called in to assess the damage and possible fixes for the Waterford High School roof. As of now, he has only been able to see the parts that are visible from the floor of the attic walkway, and would like to perform a calculation of the venting that is required before he makes any recommendations to the committee. He will be unable to do this until he can gain further access to the roof. Mr. Miner assured the committee that all damaged ceiling tiles and insulation have been removed, carpets extracted, and dehumidifiers were used to remove any water from the area that may cause more damage or grow mold. Mr. Amanti wanted to confirm that there was no electrical damage as well, which Mr. Darling stated that to the best of his knowledge there was not. Mr. Miner is going to speak with O&G and JCJ Architecture to try and determine how to fix this issue.
