# **Construction Report Waterford High School: Jay Miner**

Mr. Miner reported that almost all punch list items have been taken care of. He received a final report on the wetland basins, and it was determined that there is some debris on the back lot that has to be removed before the final walk-through. There was a meeting about the WHS roof ridge vent that included school administration, Bill Ayles from JCJ architecture, representatives from Allied Roof Restoration and O&G, as well as Mr. Wilensky and Mr. Miner. There are a number of people working on a solution to this issue, as well as some manufacturers. Ideally the work would be done over the summer while

school is not is session, and according to the architects it will take about 4 weeks to complete. Mr. Miner also brought to the committee's attention a ventilation issue in the Biology lab. During the dissection portion of the curriculum there is an odor that spreads to other classrooms due to the fact that there is no extra ventilation in the lab. There is not enough negative air to prevent the odor from travelling to the other rooms and Mr. Miner would like to get an engineer into the building to determine other possible options for exhaust air.

Mr. Wilensky inquired of Mr. Miner if he thought that on campus parking was an issue. Mr. Miner stated that during major events it most definitely is. Mr. Wilensky's concern is with the number of cars that block the roadways. Mr. Powers suggested issuing a Global Connect message at the start of the school year to parents to remind them of the "No Parking" zones.
