1. Condon Electric proposal of \$9,865.00 to install tennis court lights.

Mr. Miner stated that he had called three different electricians and this was the only one that had responded with a quote. Barring any unforeseen conditions, Mr. Condon is confident that he can replace the lighting fixtures at this price. Architect's Report Waterford High School: JCJ Architecture

Mr. Ayles was not in attendance however Mr. Belair reported on his behalf that he has almost completed uploading the LEED information. A certificate of substantial completion has been brought to Mr. Belair for review and his signature and will be brought to Rudie Beers.

Construction Report Waterford High School: Jay Miner

Mr. Miner reported that the grass on campus is coming in great and that Recreation and Parks has been doing a phenomenal job at maintaining the property. He is still working in conjunction with HHS Mechanical and others at figuring out and correcting the HVAC problem with the chillers. Mr. Miner and Mr. Belair are currently working on getting an extended warranty for this system and are awaiting reports and will discuss data further in August. Mr. Miner also commented on the carbon dioxide monitoring system that currently has an annual maintenance contract of \$25,000. Mr. Miner is looking into another option with Automated Building Systems to install thermostats that would eliminate this need for annual maintenance. He will report back to the committee on this subject in the August meeting.
